### Bulldog Puppy Contract

This puppy named \_\_\_\_\_ is sold with no known or genetic defects. The breeder/seller guarantees the puppy to be healthy at the time of sale. The breeder/seller does not assume any liability once the puppy leaves our facility. The buyer agrees to have this puppy examined by a licensed Veterinarian within 72 hours of picking up said puppy or puppy being delivered. Once the puppy has been examined within the 72 hours then buyer will email copy of vet report to breeder/seller to show puppy was examined and is in good health. This will honor contract for health guarantee.

If the veterinarian of buyers' choice finds any problems with apparent deformity or sick puppy; the breeder is to be notified immediately! A certified letter is to be sent to the breeder by the veterinarian within 24 hours of diagnosis. The breeder reserves the right to a second opinion to be obtained from a veterinarian of breeders' choice. If documentation from the veterinarian is received and a life-threatening health disease is verified, and puppy is returned at buyers' expense, then a replacement puppy of the same quality and / or purchase price will be refunded to the buyer, leaving this at breeders' option. Breeder will not accept any examination(s) performed or diagnosis' given by/from any Banfield Veterinary Clinic.

Crippling hip and elbow dysplasia and pathological spinal disorder are covered for 1 year from date of birth of said bulldog with the same conditions as above in effect. This Health Guarantee does not cover any of the following conditions: Intestinal parasites (Coccidiosis, Giardia, Worms), Kennel Cough, Pneumonia, Ear or Skin Mites, Mange (Demodectic, Sarcoptic or Cheyletiella), Cherry Eye, Allergies (food or skin), Herniation (Inguinal, Perineal or Diaphragmatic), Stenotic Nares, Small Trachea, entropion, Elongated Soft Palate, Undescended Testes, Luxated Patellas grade 1-3. This Health Guarantee does not cover any veterinarian costs associated with spaying or neutering, including undescended testes or any elective surgeries such as stomach tacking or Juvenile Pubic Symphysiodesis. Breeder does not Health Guarantee against non-life-threatening illnesses common to puppies.

Big Damn Dogs LLC guarantees puppy to be in good physical condition and healthy at the time of pickup. The buyer agrees to have the said puppy examined by a licensed veterinarian within 72 hours of delivery or this contract is null and voided immediately. (If you've known for weeks the day you are getting the puppy you should already have this day scheduled this is very important. Do not forget it.) Notice of a photocopy of expense of the veterinarian fees for the examination should be sent to [bigdamndogs@gmail.com](mailto:bigdamndogs@gmail.com) following the visit. Need a picture of the whole vet bill received. If we do not receive a notice with in 10 days but must be dated within the 72-hour period, this contract is null and void.

Big Damn Dogs LLC guarantees the said puppy to be free of any genetic/hereditary defects that cause death or serious impairment of the vital functions in the said puppy until the said puppy is one year of age. If such an inheritable defect is found and documented by a licensed veterinarian and presented to Big Damn Dogs LLC with sufficient supporting evidence, the buyer will be entitled to a replacement puppy of the same sex of comparable quality when available. (Again, buyer can pick a puppy of greater value but is responsible for price difference.) No cash refunds will be given by Big Damn Dogs LLC and Big Damn Dogs LLC will not be responsible for any veterinarian cost that said puppy may acquire. Above guarantee/warranty excludes hips and joint related issues. Buyer agrees in buying a bulldog puppy that he or she understands the certain common limitations of the bulldog breed such as joint issues and that most bulldog puppies even if X rayed will show evidence of some form of mild to moderate hip dysplasia. Loose hips on bulldog puppies are common and rarely prevent a bulldog from walking or being a functioning and loveable pet. We do not guarantee death of a heatstroke or for any monies to treat the dog for heatstroke or any other condition. Bulldogs are very susceptible to heat... Do not leave your pet in a hot house, outside or in a hot vehicle.

Every effort has been made to ensure that your puppy is as healthy as possible. However, bulldogs are prone to multiple health problems that are breed related. Buyer agrees to accept responsibility for breed related problems that are not life threatening and are easily treatable. These problems include, but are not limited to: Cherry eye, entropion or ectropion, stenotic nares, skin allergy, localized demodex and heat intolerance. Conditions that warrant return of the puppy include, but are not limited to severe hip dysplasia, generalized demodex, tracheal atresia, seizure disorder or heart defect. Big Damn Dogs LLC will NOT be responsible for any vet bills acquired. Puppies must be checked by a vet within 72 hours of purchase or health guarantee will be voided. Puppies are guaranteed for one year from the date of purchase. If a puppy is found to have a problem that warrants its return, the buyer's vet must send a certified letter that's signed and dated with the said non treatable defects/illness, buyer must not give

us the letter doing so will jeopardize the return of the puppy and possibly void the health contract. The letter must include the vet's name, address, and telephone number. No cash refunds are given for returned puppies. The puppy will be replaced with a puppy of equal value, same sex, and color, if possible, within one calendar year of its return or upcoming litter. Puppies that have been injured or exposed to contagious canine diseases are not returnable. Buyer agrees to house the bulldog puppy appropriately in a clean, climate-controlled environment, provide vaccinations, worming, heart worm prevention, proper socialization, vet care, food, and fresh water.

It is understood by the buyer this puppy at the time of sale is not guaranteed to be of show quality or of breeding quality. We cannot guarantee the said puppy will produce offspring for any reason. Buyer has researched the breed and is aware of non-life threatening problems such as cherry eye, eye entropion, elongated soft pallet, hernia and agrees these conditions care not covered in this guarantee. Buyer understands that Big Damn Dogs LLC will not be responsible under no circumstances for any veterinarian bill acquired by this said puppy.

\* NOTE: This guarantee also does not cover what in the bulldog breed is considered normal: cherry eye, entropion, skin allergies, elongated soft palate, stenotic nares, over-heating, or heat exhaustion.

#### Buyer Agrees

1. Have puppy examined by licensed veterinarian within 72 hours of pickup.
2. Provide puppy with routine preventive care, such as, but not limited to the following. annual physical examinations by a licensed veterinarian follow veterinarian guidelines for vaccinations, de-worming. and heartworm preventive.
3. Buyer agrees to not subject this puppy to hot and unbearable temperatures. Not to be left unattended or chained or tied outside or to keep this said puppy in unsanitary conditions.
4. In the event the buyer is unable to keep said puppy/dog for any reason the buyer agrees to send puppy back to breeder/seller. If the buyer returns said puppy for any reasons it will be at the buyer's expense. Breeder/seller will help in any way possible. Buyer agrees not to sell this puppy/dog to any retail company or establishment.

Breeder reserves the right to request a second opinion by another licensed veterinarian of Breeder's choosing to determine the genetic defect. This health guarantee does not cover any veterinarian or medical costs. The buyer is aware that owning a puppy means frequent visits to a veterinarian and understands that he/she will be responsible for all payments.
6. This puppy is being sold as a pet/companion only; no guarantee is made by breeder regarding the disposition, conformation, temperament, size, weight, color, or markings of said puppy. Breeder also does not guarantee that said puppy is breedable. No guarantee is made for any other traits that may develop as the puppy grows.
7. This guarantee applies to the original buyer only and cannot be transferred to another person. Any disputes must be handled in the state of Oklahoma at buyers' expense. Any changes to this contract must be in writing and agreed to and signed by both parties.
8. Buyer agrees NOT sell this puppy/dog to anyone. This contract is legal and may be enforced by legal means at the buyer's expense and all disputes must be settled in Oklahoma. This puppy/dog is being sold to said buyer as a pet only and nothing further unless otherwise noted.
9. Buyer agrees that if at any given time you can no longer care for your puppy/ dog and cannot provide him/her with a new home yourselves. We will take the said puppy/dog back but are not buying the said puppy/dog back you will be surrendering the puppy/dog back to us.
10. Shipping can be arranged at buyers' expense. If shipping is needed  $\frac{1}{2}$  of the cost will be required when the puppy is 6 weeks old to ensure they can be accommodated in a timely fashion.
11. Puppies/dogs must be fed a dog food that is of quality to their breed. Nutri-Source is what we recommend or a better-quality food. Failure to feed puppy quality food will result in health guarantee to be voided. Food is sometimes the main cause of health issues.
